The South Central Calhoun Board of Directors met in a Regular Meeting on Mon, Oct 21, 2024, at the SCC MS media center. President Judy Hun-gate called the meeting to order at 6 pm. Director members present included Vice-President Roger McKinney, Jason Hawkins, Keaton Hildreth, Jeffrey Redenius and Nick Spencer. Supt Brad Anderson, Board Secretary Carol Collins and several guests were present. Director Ryan Hammen was absent with regret.

Hildreth motioned, McKinney seconded, to approve the agenda as presented. Motion carried 6-0.

**Skilled Trades Readiness**
