Mayor Ellerbrock opened the public hearing on the fiscal year 2023 City Budget at 7:07 PM. With no citi-

zens of Lytton present to discuss the proposed budget, there was a motion by Riley, second by Toms to close the hearing. Motion carried with 5 Aye

votes. Mayor Ellerbrock closed the public hearing at 7:09 PM. Riley and Wuebker discussed bringing a Corn Belt Fiberoptics connection to Lytton. It was decided to organize a meeting on May 14, 2022 between

1:00 and 3:00 PM at the Legion Hall to address questions and services. Wuebker left at 7:22 PM. Motion to approve a building permit for a dog kennel at 417 4th St. by Townsend, second by Riley. Motion carried with 5 Ayes.

Meyer and Kellen left at 7:26 PM. After discussion, the council approved con-

tinuing citywide garbage pickup with Rudd Sanitation at a rate of \$1800.00

per month for one year. The City Clerk will write up the contract and present

it to the council in April. Mr. and Ms. Rudd left at 7:34 PM. Motion to approve Resolution 22-04 A Resolution Approving the Transfer of Funds from the ARRA Fund to the Sewer Fund by Coon, second by Toms. Motion carried

with 5 Ayes. \$21,606.07 will be transferred for use on the sewer main project. Motion to approve Resolution 22-08 a Resolution Approving the Lytton Annual Budget for Fiscal Year 2022-2023 by Townsend, second by Riley.

Motion carried with 5 Aye votes. Motion to set April 4, 2022 as the date for the public hearing for fiscal year 2022 budget amendment #2 by Townsend, second by Coon. Motion carried with 5 Ayes. The date for a public hearing and bid letting for the sewer main project were not addressed at this time.

Motion to approve a one-time payment of \$250.00 to fund the Council of

Governments Housing, Inc. by Coon, second by Townsend. Motion carried

with 5 Aye votes. Motion to approve the first reading of Ordinance 22-01 Amending the Trash Pickup Rate Ordinance by Coon, second by Townsend. Motion carried with 5 Ayes. Motion to approve the first reading of Ordinance 22-02 Amending the Water Rate Ordinance by Coon, second by Riley. Motion carried with 5 Aye Votes. Motion to approve the first reading of Ordinance

22-03 Amending the Sewer Rate Ordinance by Coon, second by Meyer. Motion carried with 5 Ayes. All utility rates will be raised by 10% starting July 1, 2022. The new rate for an individual home will be approximately \$98.50 per

month. The complete ordinances will be posted at the library, bank and post office, city hall and the City of Lytton Facebook page.

Public Works update was given by Brown and Mayor Ellerbrock gave an update. Motion to approve the purchase of two air quality monitors by Coon,

second by Riley. Motion carried with 5 Ayes. Motion to approve use the city lot to the west of the water tower for food and beer garden during Gala Days

Further discussion of a dog park in Lytton took place. No decisions were made. Improving access to Well #4 and Well #5 near the Lagoon was discussed. This will be readdressed at the April meeting. One nuisance property was discussed. Motion to approve three shut off notices and 4 account adjustments by Coon, second by Townsend. Motion carried with 5 Ayes. A
